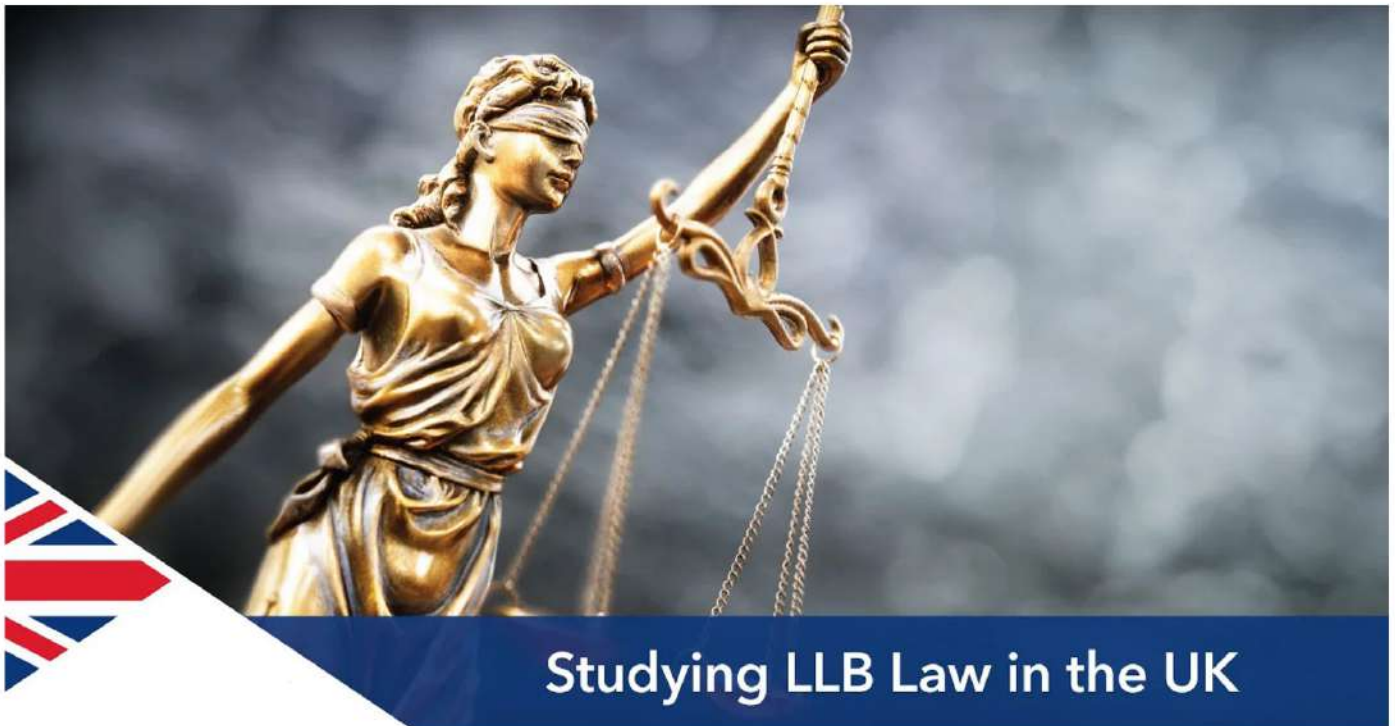

Masters in Law in UK: Top Universities, Eligibility, Fees, Scholarships, Scope

Masters in Law in UK is 9 months to 1-year full-time degree available as Master of Science (MS), LLM and Master of Law degree. Often available for only full-time study to international students, LLM in UK can cost around 19,5000 GBP to 44,000 GBP a year. For an Indian aspirant the cost of studying master's from [law schools in UK](#) goes up to 40 lakhs a year.

The cost may seem too high for a student on a budget. However, there are plenty of [scholarships in UK](#) available for international students. When planning to pursue master's in law in UK, you can choose from specializations like criminal law, family law, employment law, and many more. As the course is offered by some of the top-tier universities in UK, finding high-paying [jobs in the UK](#) with a master's in law is a piece of cake Some of the most popular careers after completion of your LLM are solicitor and barrister. The average earning is 83,000 GBP per annum which is approximately equal to 81 lakhs. Hence, the ROI for LLM in the UK is very high.

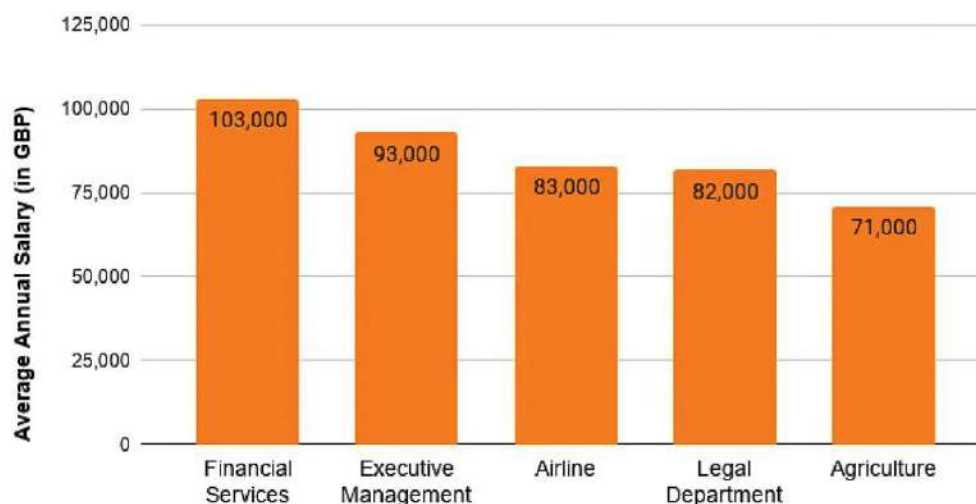

Why Study LLM in UK?

Given below are a few reasons why the UK is one of the best countries around the globe for studying in UK:

- According to QS World University Rankings for Law (2022), 8 universities of the UK ranks among the top 10 universities around the world offering law degrees.
- Average salary earned by individuals in the legal sector is 20% more than the average of all jobs in the UK.
- The increment in paygrade in this sector is 11% per annum while the UK's average for all jobs is only 7%.
- Legal Department is the 4th highest paying sector for graduates and alumni of UK universities.

Course Structure of LLM in UK

LLM in the UK is composed of a total of 180 credits out of which 120 credits are for taught courses and 60 credits are for dissertation. The dissertation is usually 14,000 to 15,000 words long and is based on the specialization chosen by a student.

Admission Process for LLM in UK

To successfully [apply in universities of the UK](#), you need to fulfill the following basic eligibility requirements:

- A bachelor's degree in law, sociology, politics, economics, social policy, psychology, history; or another subject relevant.
- [IELTS](#) or [TOEFL](#) test scores as proof of English language proficiency

For an MSc in Criminology and Criminal Justice at the University of Oxford: If you failed to meet the required standard for an undergraduate degree, having extensive employment experience within the field of criminal justice may be regarded by the Board of Admissions.

Scope of LLM in UK

A law degree is a gateway to a career as a solicitor or barrister, but it's not the only path one can choose. Many options are available for individuals with a Masters in Law. Jobs directly related to law degree include Arbitrator, Barrister, Lawyer, Paralegal, and Legal Executive.

Practicing Law in UK with LLM

UK judiciary system is different for all four parts: England, South Wales, Scotland, and Northern Ireland. However, England and Wales have the same legal jurisdiction and courts. The process of becoming a barrister and solicitor is also different.

Barristers represent clients in courts and advise them on legal matters. Clients could be individuals or organizations. They earn an average annual salary of 51,310 GBP (4.9 lakhs INR). Three stages of becoming barrister are as follows:

- Academic Component: A law degree
- Vocational Component: Bar Professional Training Course (BPTC)

- Pupillage: Work-based learning

Solicitors are responsible for providing legal support, advice, and services to clients. They can be individuals, private companies, or public sector organizations. To become a solicitor, students are required to complete a vocational Legal Practice Course (LPC), undertake a training contract with a law firm, and pass a professional skills course. The average salary offered to them in UK is 37,331 GBP (3.5 lakhs INR) per annum. Students with Masters in Law in the UK can seek employment in major firms such as Allen & Overy, Clifford Chance, Freshfields Bruckhaus Deringer, Linklaters, Slaughter, and May.

Practicing Law in India with LLM in UK

Indian students also have the option of returning back to the country and practice as a lawyer. Bar Council of India (BCOI) currently recognizes 35 UK universities offering a law degree. It has been observed that Indian law firms treat new graduates of both countries equally in terms of salary offered. However, if someone has 3 to 4 years of experience of working in a UK law firm before returning to India, he/she may get a higher paygrade than what is offered to Indian graduates with similar work experience.

The registration process of becoming a lawyer in India with a degree from BCOI recognized UK university are as follows:

- Apply at a State Bar Council forwards the application to Bar Council of India
- Pass all six subjects of the exam

Students not having a degree from a recognized UK university can also practice law in India if approved by the Bar Council of India. Entry-level salaries for lawyers in this country are tabulated below:
